THE TWELVE TRADITIONS of NA

We keep what we have only with vigilance, and just as freedom for the individual comes from the Twelve Steps, so freedom for the group springs from our Traditions. As long as the ties that bind us together are stronger than those that would tear us apart, all will be well.

1. Our common welfare should come first; personal recovery depends on NA unity.
2. For our group purpose there is but one ultimate authority a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.
3. The only requirement for membership is a desire to stop using.
4. Each group should be autonomous except in matters affecting other groups or NA as a whole.
5. Each group has but one primary purpose-to carry the message to the addict who still suffers.
6. An NA group ought never endorse, finance, or lend the NA name to any related facility or outside enterprise, lest problems of money, property, or prestige divert us from our primary purpose.
7. Every NA group ought to be fully self-supporting, declining outside contributions.
8. Narcotics Anonymous should remain forever Non-professional, but our service centers may employ special workers.
9. NA, as such, ought never be organized, but we may create service boards or committees directly responsible to those they serve.
10. Narcotics Anonymous has no opinion on outside issues; hence the NA name ought never be drawn into public controversy.
11. Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films.
12. Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles before personalities.

MAKAPALA SITE HOUSE RULES

- Though tempting, please refrain from climbing the trees, especially the big one in the front yard.
- No Pets, No Smoking and No Alcohol are allowed on property.
- All groups are responsible for their own bedding, toiletries, dry goods, food, and food prep.
- The accommodations have been cleaned before you arrive. You are responsible for thoroughly cleaning before your group departs.
- Shoes & Slippers must be removed in all buildings/ rooms with the exception of the kitchen, dining room, and downstairs lounge area in the main building.
- There are no food or drinks (other than water!) permitted in the bedrooms and classrooms.
- If planning a hike down Pololu Valley, please BE CAREFUL and DO NOT SWIM! There is a STRONG current that is *very* dangerous.
